# **CII/MIMOSA MOU**Reasons for Collaboration

- MIMOSA is a Standards Development Organization, while CII focuses on Industry/Best Practices.
- Together, the CII/MIMOSA Joint Working Group (JWG) will develop Interoperability Best Practices based on Standards.






# CII/MIMOSA MOU – Key Points of Alignment Foundation for CII/MIMOSA Interoperability JWG

- CII and MIMOSA wish to align in order to help industry achieve standards-based interoperability in capital projects based on the Open Industrial Interoperability Ecosystem (OIIE) and International Standards Organization (ISO) 18101.
- The organizations intend to form a Joint Working Group which will team to develop formal OIIE Use Cases based on Industry Functional Requirements developed by CII.
- CII and MIMOSA will retain ownership of their respective intellectual property while agreeing on appropriate branding of the jointly developed OIIE Use Cases.
- The OIIE Use Cases will be defined using the OIIE Use Cases Architecture, seeking the re-use of appropriate OIIE Scenarios and Events, many of which may already exist.
- The OIIE Intra-Enterprise and Inter-Enterprise IT Architecture (which also incorporates IEC Standards and other industry standards) will be used as is shown in ISO 18101-1.
- These OIIE Use Cases will be validated in the OIIE Oil and Gas Interoperability (OGI) Pilot before they are published and licensed for use on a world-wide royalty free basis.
- Once the jointly developed OIIE Use Cases are validated in the pilot, CII and MIMOSA intend to submit them to ISO TC 184/WG 6 for inclusion in future parts of ISO 18101.

    - Reference material on process for Use Case Development
    - Example data and docs/doc metadata
- Data Model Mapping
  - 3-way (AWP, CCOM, CFIHOS)
  - MIMOSA CCOM Persistence Model
    - Refine use case involving Tags and Properties (proposal is to link it to the purchasing use case)
    - o Link to OIIE digital services for exchange, back-end using DB-to-DB mapping leveraging the persistence model
    - Persistence of CCOM in a relational database
